## BOARD OF DIRECTORS

### **Claudio Sulser, Chairman of the Board of Directors**

Claudio Sulser joined Banca Zarattini in 1996 and became Chairman of the Board of Directors in 2004. He is recorded in the Register of Certified Lawyers, and has practiced as a lawyer with Sulser Jelmini Padlina & Partner, a firm of lawyers and notaries, since 1996. A law graduate from Zurich University, Mr Sulser gained experience in a variety of positions in legal departments in Credit Suisse, Km Office and CS ElvisimGroup. He has an illustrious past in football, when he was one of the strongest strikers in the Swiss national team. He has subsequently held prestigious roles in FIFA's ethics committee, disciplinary committee and anti-racism and anti-discrimination task force. Also, he has been a delegate of the Swiss national football teams.

### **Andrea Zanni, Vice Chairman of the Board of Directors**

Andrea Zanni joined Banca Zarattini in 1992 as a shareholder and director of the group, where he held the role of Head of marketing and customer management. He has been a member of the Board of Directors of Banca Zarattini since 2006. In 1993, he became an authorised financial trustee in Ticino. Camilla Zarattini is the widow of Mario Zarattini, the founding shareholder of the Zarattini Group. As the founding member's heir, Camilla Zarattini, who holds a diploma from the commercial and technical institute, represents the Group's values and identity, and is the majority shareholder. The Zarattini Group, which was founded in Italy in 1985, relocated to Lugano in 1991. In the same year, the Group sponsored Martin Group Ltd, a hedge fund based in the British Virgin Islands; this was followed by the launch of Timeo Neutral Sicav in 2003. In 2001, the Group's subsidiary, Zarattini & Co SA, obtained a licence as a securities dealer from the Swiss Federal Banking Commission (now FINMA). In 2005, the Group obtained a banking licence. Thereafter, Banca Zarattini implemented its external and internal growth strategy: in 2011, it acquired the brokerage division of Prometeo Investment Services SA, followed by Banca Euromobiliare (Suisse) in 2012 and Banca Intermobiliare di Investimenti e Gestioni (Suisse) SA in 2017. In 2015, the Group acquired an international dimension via Zarattini International Ltd, the sister company of Banca Zarattini, based in Malta.

### **Giulio Zarattini, Member of the Board of Directors**

Giulio Zarattini has been a member of the Board of Directors of Banca Zarattini & Co. since 2024. Driven by a deep interest in the economic and financial market, he graduated in economics from the Catholic University of Milan, and then specialised at the London School of Business and Finance where he obtained a postgraduate master's degree in finance.
